The Governor in Council on the report and recommendation of the Minister of Transportation and Infrastructure Renewal dated November 12, 2009, and pursuant to Section 19 of Chapter 235 of the Revised Statutes of Nova Scotia, 1989, the *Interpretation Act*, and pursuant to Section 21 of Chapter 371 of the Revised Statutes of Nova Scotia, 1989, the *Public Highways Act*, is pleased to:

- (a) rescind Order in Council 77-1280 dated October 18, 1977, which designated as controlled access a section of highway known as Highway 103 together with its interchanges, intersections, ramps and highway connectors, in the counties of Shelburne and Yarmouth, beginning at the point of intersection of the center line of Highway 103 and the center line of the Oak Park Road at Oak Park, in the County of Shelburne and extending in a northerly direction a distance of approximately 11.5 miles to the proposed new highway connector at Pubnico Head:
- (b) designate as a controlled access highway a section of Highway 103, together with its interchanges, intersections, ramps and new highway connectors, beginning at a point 200m east of the intersection of the center line of Highway 103 and the center line of Trunk 3 east of Barrington in Shelburne County (Exit 29) and extending in a westerly direction a distance of approximately 26.0 kilometers to the center line of the highway connector at Pubnico Head (Exit 31);
- (c) designate as a controlled access highway a new section of highway known as the Oak Park Connector from the intersection of the center line of Oak Park Road and the center line of the Oak Park Connector and extending approximately 700m to a point 100m north of the intersection of the center line of the Oak Park Connector and the center line of the Highway 103 westbound ramps at Exit 30; and

(d) designate as a controlled access highway a section of highway known as the Pubnico Connector from the intersection of the center line of Trunk 3 and the center line of the Pubnico Connector and extending approximately 0.5 km to the intersection of the center line of the Pubnico Connector and the center line of Highway 103 at Exit 31.
