Whereas the Federal Minister and the Provincial Minister, pursuant to subsection 141(1) of the *Canada-Nova Scotia Offshore Petroleum Resources Accord Implementation Act* and subsection 134AA(1) of the *Canada-Nova Scotia Offshore Petroleum Resources Accord Implementation (Nova Scotia) Act*, issued the *Joint Notice Specifying [Establishing] the Prohibition Period for Certain Activities on Georges Bank* on April 11, 2016 which imposed a prohibition period that expires

on December 31, 2022;

And whereas after having reviewed the environmental and socio-economic impact of exploration and drilling activities in that portion of the offshore area described in Schedule IV of the Acts, and all other relevant factors, the Federal Minister and the Provincial Minister wish to extend, for a period of ten years, the prohibition period set out in that Joint Notice;

Therefore, the Federal Minister and Provincial Minister, pursuant to subsection 141(2)a of the *Canada-Nova Scotia Offshore Petroleum Resources Accord Implementation Act* and subsections 134AA(2) and 134AA(3) of the *Canada-Nova Scotia Offshore Petroleum Resources Accord Implementation (Nova Scotia) Act*, makes the annexed *Joint Notice Extending the Prohibition Period for Certain Activities on Georges Bank*.

Prohibition Period

- 1 For the purpose of subsection 134AA(2) of the *Canada-Nova Scotia Offshore Petroleum Resources Accord Implementation (Nova Scotia) Act*, the exploration of drilling for and the production, conservation and processing of petroleum in that portion of the offshore area described in Schedule IV of that Act, and the transportation of petroleum produced in that portion of the offshore area are prohibited for a period beginning on January 1, 2023 and ending on December 31, 2032.
