Retail Business Uniform Closing Day Act

The Governor in Council on the report and recommendation of the Minister responsible for the *Retail Business Uniform Closing Day Act* dated October 5, 2006, and pursuant to subsection 3(2) and Section 8 of Chapter 402 of the Revised Statutes of Nova Scotia, 1989, the *Retail Business Uniform Closing Day Act*, is pleased, effective on and after October 6, 2006, to

- (a) repeal the *Retail Business Uniform Closing Day Regulations*, N.S. Reg. 98/2006, made by the Governor in Council by Order in Council 2006-315 dated June 28, 2006; and
- (b) make new regulations respecting retail business uniform closing days in the form set forth in Schedule "A" attached to and forming part of the report and recommendation.

1 These Regulations may be cited as the *Retail Business Uniform Closing Day Regulations*.

Exemptions from Section 3 of the Act

2 All goods and services sold, offered for sale or purchased by retail are prescribed as goods and services to which Section 3 of the *Retail Business Uniform Closing Day Act* does not apply.

NOW KNOW YE THAT WE, by and with the advice of the Executive Council of Nova Scotia, do by this Our Proclamation order and declare that Chapter 4 of the Acts of 2006, the *Police and Peace Officers' Memorial Day Act*, come into force on and not before October 10, 2006, of which all persons concerned are to take notice and govern themselves accordingly.
