Trade Union Procedure Regulations

Order in Council 2010-359 dated September 28, 2010

Amendment to regulations made by the Labour Relations Board and approved by the Governor in Council pursuant to Section 18 of the *Trade Union Act*

The Governor in Council on the report and recommendation of the Minister of Labour and Workforce Development dated September 1, 2010, and pursuant to Section 18 of Chapter 475 of the Revised Statutes of Nova Scotia, 1989, the *Trade Union Act*, is pleased to approve the amendments made by the Labour Relations Board (Nova Scotia) to the regulations governing trade union procedure, N.S. Reg. 101/72, made by the Labour Relations Board and approved by the Governor in Council by Order in Council 72-933 dated August 29, 1972, to remove the forms from the regulations, change the definition of "member in good standing" and the criteria for proof of membership, and introduce expedited hearing procedures relating to jurisdictional disputes, in the manner set forth in Schedule "A" attached to and forming part of the report and recommendation, effective on and after September 28, 2010.

Schedule "A"

I certify that the Labour Relations Board (Nova Scotia), pursuant to Section 18 of Chapter 475 of the Revised Statutes of Nova Scotia, 1989, the *Trade Union Act*, on or before August 30, 2010, unanimously approved the amendments to the regulations governing trade union procedure, N.S. Reg. 101/72, made by the Labour Relations Board and approved by the Governor in Council by Order in Council 72-933 dated August 29, 1972, to remove and repeal the forms from the regulations, change the definition of "member in good standing" and the criteria for proof of membership and introduce expedited hearing procedures relating to jurisdictional disputes, in the manner attached.

These amendments to the regulations are effective on and after the date they are approved by the Governor in Council.

Amendment to the Regulations Governing Procedure made by the Labour Relations Board (Nova Scotia) under Sections 18 and 94 of Chapter 475 of the Revised Statutes of Nova Scotia, 1989, the *Trade Union Act*

- 1 (1) Subsection 3(2) of the regulations governing procedure, N.S. Reg. 101/72, made by the Labour Relations Board and the Construction Industry Panel of the Labour Relations Board and approved by the Governor in Council by Order in Council 72-933 dated August 29, 1972, is amended by striking out "Where a document in a form provided for by these regulations is required by these regulations to be filed with the Board" and substituting "Where these regulations require a document to be filed with the Board in a form approved by the Board,".
 - (2) Section 3 is further amended by striking out "form and" in subsection (3).
- 2 Subsection 5(3) of the regulations is amended by striking out "prescribed by the Act or these regulations" and substituting "submitted to the Board".
- 3 Subsection 8(1) of the regulations is amended by striking out "in triplicate in Form 21" and substituting "in a form approved by the Board".
- 4 (1) Subsection 9(1) of the regulations is amended by striking out "in triplicate in Form 1," and substituting "in a form approved by the Board and".
 - (2) Clause 9(2)(c) of the regulations is repealed and the following clause substituted:
 - (c) a list of employees applied for who are members in good standing of the union supported by their membership cards or, where the Board is satisfied that membership cards are not reasonably available, other membership evidence relating to the application;

 - (2A) To be considered by the Board, a membership card must be in writing, be signed by the employee concerned, and disclose the date on which the signature was obtained.

 - As at the date of filing of an Application for Certification by a trade union, for purposes of the Application for Certification a person is deemed to be a member in good standing of the trade union if the person joined or signed an application for membership in the trade union
 - (a) within the period from the first day of the third month preceding the calendar month in which the Application for Certification is made to the date of the Application for Certification; or
 - (b) before the period set out in clause (a) and, for any portion of that period, has paid to the trade union an amount in respect of fees or dues of the trade union supported by a receipt or other evidence acceptable to the Board that the fees or dues have been paid.

 - (1) The Chief Executive Officer shall serve the respondent with all of the following:
 - (a) a Notice of Application for Certification;

- (c) one or more copies of a Notice to Employees of Application for Certification, for posting.
- (2) Subsection 11(2) of the regulations is amended by

- (3) Subsection 11(3) of the regulations is amended by

 - (b) striking out "Return of Posting in Form 4" and substituting "completed Return of Posting, in a form approved by the Board".

- (i) make or cause to be made any examination of records or other inquiries that it considers necessary in the circumstances.

Grade 1 Regular gasoline 53.9¢ per litre Ultra-low-sulfur diesel oil 59.3¢ per litre

Now therefore the Board prescribes the benchmark prices for petroleum products to be:

Gasoline:

Grade 1 53.9¢ per litre
Grade 2 56.9¢ per litre
Grade 3 59.9¢ per litre
Ultra-low-sulfur diesel oil 59.3¢ per litre

And now therefore the Board has determined, based on historical data regarding price changes and to achieve revenue neutrality, it is appropriate to apply, and the Board so orders, forward averaging corrections of:

Gasoline: plus 0.6¢ per litre Ultra-low-sulfur diesel oil: plus 0.9¢ per litre

And whereas a winter blending adjustment of plus 0.4¢ per litre is required for ultra-low-sulfur diesel oil;

And now therefore the Board prescribes the prices for petroleum products as set forth in Schedule "A" effective on and after 12:01 a.m., October 1, 2010.
