Multi-Day Charters: to amend its Charter Rates, Tolls and Charges based on distance zones of 200 km. rather than 300 km., plus applicable taxes, as set out in the attached Schedule "B". The effective date is to be upon Order of the Board.

Also, to increase the overnight charge from \$130 to \$150; to increase the cost for additional drive from \$275 to \$360; and to change the "Low Season" period to which a 10% discount applies (for both single day and multi-day charters) from November 1 - June 14 to October 16 - May 14.

1. Deposit

- 25 % of the total charter charges (net of taxes) shall be paid by the customer as a deposit not later than 90 days prior to trip departure.
- This amount shall be retained by the carrier and may be applied to any amounts payable by the customer under this contract including charter charges, cancellation charges and any costs, damages or losses for which the customer is responsible.

2. Payment

- Full payment of the balance of total charter charges (including all taxes) shall be paid not later than 30 days prior to departure date.

3. Additional Charges

- The customer acknowledges and agrees that in addition to the contract price set forth in this contract, the customer shall be responsible for and pay immediately when payable all costs for driver's accommodations, park entrance fees, attractions or admission fees, bridge tolls, road tolls and ferry tolls.

4. Standby Charges

- Where this contract provides for one or more coaches to be on "standby" the customer agrees to pay, in addition to any other charges payable under this contract, a standby charge of \$350.00 for each coach on standby which is not utilized by the customer for the trip for which it was on standby; provided that the cancellation charges in paragraph 5 shall not apply to standby coaches.

5. Cancellation charges

- Charges for cancellation of a charter trip by the customer shall be paid to the carrier based upon the following percentages of the total charter charges:
 - a) 10% if notice of cancellation is given more than 45 days prior to the trip
 - b) 25% if notice of cancellation is given between 31 and 45 days prior to the trip
 - c) 50% if notice of cancellation is given between 14 and 30 days prior to the trip
 - d) 75% if notice of cancellation is given between 7 and 13 days prior to the trip
 - e) 100% if notice of cancellation is given less than 7 days prior to the trip.

6. Charter cancellation by the customer

- The customer may cancel the trip organized by the carrier only upon prior written notice to the carrier and subject to the customer paying the cancellation charges in paragraph 5 above.

7. Charter cancellation by the carrier

- The carrier reserves the right to cancel any scheduled charter trip or discontinue operating any trip already in progress due to factors beyond its control (including, but not limited to, the reasons described in paragraph 8 below) if carrying out the trip would put the safety of the passengers or the driver in jeopardy.
- The carrier also reserves the right to cancel charter trip for any reason upon not less than 180 days prior notice to the customer. The carrier will, in that event, use commercially reasonable efforts to outsource the trip to another carrier and to assure a comparable level of high quality service.
- The carrier will not be held responsible for any inconvenience or any damages that may result, directly or indirectly, from a decision to cancel a charter trip pursuant to this paragraph 6.

8. Customers schedules and delays

- A detailed itinerary in compliance with this contract must be delivered by the customer to the carrier 30 days prior to departure to ensure hours of service.
- Every effort will be made by the carrier to achieve the scheduled hours for departure and arrival, as well as the itinerary set out in the contract.
- The carrier will not be held liable for any delays which may result from accidents, mechanical breakdowns, detours, poor highway conditions, snow storms, traffic congestion or any other factors beyond its control.
- It shall be the sole decision of the carrier whether or not it is safe or advisable to operate the coach in any situation.
- The customer agrees to pay any additional charges and expenses that may arise as a result of any changes made by the customer to the detailed itinerary made later than the date 30 days prior to departure.

9. Personal items lost, stolen, or damaged

- The carrier will not be held responsible for the value of any passenger's articles lost, stolen or damaged during a charter trip beyond the amount of \$100 and, to that extent, only in respect of articles stored in the under floor storage compartment.
- The customer must notify the carrier of any and all such claims within the 30 days next following the end of the charter trip.
- The carrier will not be liable for passengers' luggage while it is in the personal possession of the passengers or inside the coach passenger area.

10. Luggage

- Only light items that are not dangerous or do not have sharp points may be stored in the overhead racks inside the coach.
- All luggage, heavy items and sharp items must be stored in the under floor storage compartment.
- No one can carry in their luggage or on their person any illegal or dangerous items such as guns, weapons, explosives, nitro-glycerine, dynamite, etc.

11. Animals

- No animals will be transported in the coach except a guide dog for a visually impaired person.

12. Customer and passenger behaviour

- Federal & provincial regulations prohibit smoking and/or alcohol on all charter trips.
- This requirement is in effect from the commencement to the end of the charter trip.
- The carrier may refuse to provide or continue transportation to any person exhibiting unacceptable behaviour which shall include, but not be limited to, the following :
 - .. A person who is impaired by alcohol or drugs
 - .. A person conducting himself or herself in a boisterous or disorderly manner
 - .. A person using profane or obscene language
 - .. A person conducting himself or herself in a manner objectionable or threatening to the other passengers or the driver.
- The customer hereby acknowledges that it is fully responsible for the behaviour of all the passengers on the charter trip.
- If any unacceptable behaviour results in damage to the carrier's equipment, the customer agrees to reimburse the carrier for any costs required to replace such equipment or repair or return the equipment to its original state of operation prior to such damage.

13. Terms & conditions

- The carrier and the customer (on its behalf and on behalf of all passengers on the charter trip) agree to be bound by all terms and conditions in his contract.
- The customer agrees to indemnify and save harmless the carrier from and against any claim by any passenger against the carrier other than a claim which the customer would have been entitled to make pursuant to this contract in the same circumstances.

- A booking constitutes a contract. For a booking to be a contract, this document must be signed jointly by customer and carrier.
- Quotations are not contracts.
- All agreements between the parties in respect of the charter trip are contained within this contract. This contract shall be interpreted in accordance with the laws of the Province of Nova Scotia.
