Sixteen passenger mini buses are restricted to a maximum seating capacity of 15 passengers, including the driver, when traveling via the Confederation Bridge to or from Prince Edward Island. All points of exit and entry.

Rates for this vehicle are unchanged, at \$1.25 per hour or \$20.00 minimum charge per hour per trip, whichever is greater.
