Whereas the purpose of the *Petroleum Products Pricing Regulations* is to ensure just and reasonable prices for specified petroleum products taking into consideration the objectives of preserving the availability of such products in rural areas, stabilizing prices of such products and minimizing the variances in prices of such products across the Province;

And whereas the Nova Scotia Utility and Review Board ("Board") considered the manner in which it would proceed to set petroleum prices in its decision, 2006 NSUARB 108, issued on October 16, 2006;

And whereas the average of the average of the daily high and low reported product prices (in Canadian cents) for the week ended April 28, 2010, are:

Grade 1 Regular gasoline 59.1¢ per litre Ultra-low-sulfur diesel oil 60.7¢ per litre

Now therefore the Board prescribes the benchmark prices for petroleum products to be:

Gasoline:

Grade 1 59.1¢ per litre
Grade 2 62.1¢ per litre
Grade 3 65.1¢ per litre
Ultra-low-sulfur diesel oil 60.7¢ per litre

And now therefore the Board has determined, based on historical data regarding price changes and to achieve revenue neutrality, it is appropriate to apply, and the Board so orders, forward averaging corrections of:

Gasoline: plus 0.3¢ per litre Ultra-low-sulfur diesel oil: plus 0.4¢ per litre

And now therefore the Board prescribes the prices for petroleum products as set forth in Schedule "A" effective on and after 12:01 a.m., April 30, 2010.

Licensing of Insurers Regulations

Order in Council 2010-195 dated May 4, 2010 Amendment to regulations made by the Governor in Council pursuant to subsection 5(3) of the *Insurance Act*

The Governor in Council on the report and recommendation of the Minister of Finance dated April 11, 2010, and pursuant to subsection 5(3) of Chapter 231 of the Revised Statutes of Nova Scotia, 1989, the *Insurance Act*, is pleased to amend the *Licensing of Insurers Regulations*, N.S. Reg 142/90, made by the Governor in Council by Order in Council 90-629 dated May 22, 1990, to change from annual licensing to three-year licensing, in the manner set forth in Schedule "A" attached to and forming part of the report and recommendation, effective on and after May 4, 2010.

Schedule "A"

Amendment to the *Licensing of Insurers Regulations*made by the Governor in Council under subsection 5(3) of Chapter 231 of the Revised Statutes of Nova Scotia, 1989, the *Insurance Act*

- 1 (1) Subsection 5(2) of the *Licensing of Insurers Regulations*, N.S. Reg 142/90, made by the Governor in Council by Order in Council 90-629 dated May 22, 1990, is repealed and the following subsection substituted:
 - (2) The total license fee or license renewal fee payable by any insurer or inter-insurance exchange shall not exceed \$1790.72 per year of the license term.
 - (2) Subsection 5(3) of the regulations is amended by striking out "Annual license or renewal fees" and substituting "License fees or license renewal fees".
- 2 Section 7 of the regulations is repealed and the following Section substituted:
 - 7 (1) A license to carry on the business of insurance in the Province must be in the form determined by the Superintendent and shall specify the class of insurance to be carried on by the insurer.
 - (2) Unless it is suspended or cancelled sooner, a license expires
 - (a) 3 years after the date it is issued or renewed; or
 - (b) on a date earlier than 3 years from the date it is issued or renewed, as set by the Superintendent for a particular licence or class of licences.
 - (3) A license may be renewed on application to the Superintendent.
- 3 Schedule "A" to the regulations is amended by
 - (a) adding the following sentence immediately before the table:
 - The yearly rate for licence fees and licence renewal fees is as set out in the following table for the class of insurance to be carried on by the insurer:
 - (b) striking out "Annual License or Renewal Fee" in the heading to the second column of the table and substituting "Yearly Rate for License Fee and License Renewal Fee".

Summary Offence Tickets Regulations

Order in Council 2010-207 dated May 11, 2010

Amendment to regulations made by the Minister of Justice and the Governor in Council pursuant to Section 8 of the *Summary Proceedings Act*

The Governor in Council on the report and recommendation of the Minister of Justice and Attorney General dated April 21, 2010, and pursuant to Section 8 of Chapter 450 of the Revised Statutes of Nova Scotia, 1989, the *Summary Proceedings Act*, is pleased to amend the *Summary Offence Tickets Regulations*, N.S. Reg. 4/2001, made by the Governor in Council by Order in Council 2001-21 dated January 18, 2001, to designate certain offences under the *Motor Vehicle Act* as summary offence ticket offences and set the out-of-court settlement amounts for the offences in the manner set forth in Schedule "A" attached to and forming part of the report and recommendation, effective on May 11, 2010.

Order

I, Ross Landry, Minister of Justice and Attorney General of Nova Scotia, hereby order and direct pursuant to Section 8 of Chapter 450 of the Revised Statutes of Nova Scotia, 1989, the *Summary Proceedings Act*, that the penalty to be entered on a summons in respect of an offence set out in the amendments to Schedule 4 to the *Summary Offence Tickets Regulations*, N.S. Reg. 4/2001, as set forth in Schedule "A", is the amount of the out-of-court settlement set out in clause 5A(1)(b) of the *Summary Offence Tickets Regulations* that corresponds to the offence category set out opposite the description of the offence in Schedule "A", and the out-of-court settlement amount includes the charge provided for in, and in accordance with, Sections 8 and 9 of the Act.

This Order is effective on and after the making by the Governor in Council of the amendments to the *Summary Offence Tickets Regulations* set out in Schedule "A".
