made under subsection 9(1) and clause 11(d) of the *Natural Products Act***

Section 2.05 of the regulations respecting the production and marketing of eggs in Nova Scotia, approved by Governor in Council by Order in Council 85-1259, dated November 19, 1985, is amended by striking out "100,000" in clause (a) and substituting "275 000".
