And whereas the Board revised the wholesale margin effective January 4, 2013, in its decision, 2012 NSUARB 213, issued on December 12, 2012;

And whereas the Board revised the retail margin and the transportation allowance effective October 28, 2016, in its decision, 2016 NSUARB 168, issued on September 26, 2016;

And whereas the average of the average of the daily high and low reported product prices (in Canadian cents) for the period ended May 13, 2020, are:

Grade 1 Regular gasoline	30.95¢ per litre

Order in Council 2020-157 dated May 26, 2020
Amendment to regulations made by the Governor in Council
pursuant to Section 15 of the *University Foundations Act*

The Governor in Council on the report and recommendation of the Minister of Labour and Advanced Education dated April 28, 2020, and pursuant to Section 15 of Chapter 8 of the Acts of 1991, the *University Foundations Act*, is pleased to amend the *University Foundations Regulations*, N.S. Reg. 63/1993, made by the Governor in Council by Order in Council 93-333 dated April 6, 1993, in the manner set forth in Schedule “A” attached to and forming part of the report and recommendation effective on and after May 26, 2020.

Schedule “A”

**Amendment to the *University Foundations Regulations*
made by the Governor in Council under subsection 15(1)
of Chapter 8 of the Acts of 1991,
the *University Foundations Act***

- 1 Clause 1(c) of the *University Foundations Regulations*, N.S. Reg. 63/1993, made by the Governor in Council by Order in Council 93-333 dated April 6, 1993, is amended by striking out “Education” and substituting “Labour and Advanced Education”.
- 2 Section 2 of the regulations is repealed and the following Section substituted:
 - 2 The following institutions are hereby designated as universities for the purpose of the Act:
 - (a) Acadia University;
 - (b) Nova Scotia College of Art and Design;
 - (c) Cape Breton University.
- 3 The regulations are further amended by repealing Section 5.
