The *Milk Pricing Regulations*, N.S. Reg. 84/2008, made by the Dairy Farmers of Nova Scotia on September 21, 2007, and approved by the Natural Products Marketing Council on February 12, 2008, are amended by repealing subsection 3(1) and substituting the following subsection:

- 3 (1)** Except as provided in subsection (2), the prices payable by processors in Nova Scotia for milk components are as set out in the following table, and are payable on a free on board (FOB) plant basis:

- 2 Section 14 of the regulations is amended by
  - (a) adding “or fluid milk” immediately after “milk” in clause (b); and
  - (b) adding “, fluid milk” immediately after “milk” in clause (c).
- 3 Clause 16(2)(b) of the regulations is amended by adding “or fluid milk” immediately after “milk”.
- 4 Section 22 of the regulations is amended by
  - (a) adding “or fluid milk” immediately after “milk” in subsection (1); and
  - (b) adding “or fluid milk” immediately after “milk” in subsection (2).
- 5 Section 23 of the regulations is amended by adding “or fluid milk” immediately after “milk” wherever it appears.
- 6 Section 24 is amended by adding “fluid” immediately after “reconstituted”.
- 7 Section 25 is amended by adding “fluid” immediately after “temperature”.
