Regulations approved by the Governor in Council
pursuant to Section 45
of the Dental Act

The Governor in Council on the report and recommendation of the Minister of Health dated September 9, 2002, and pursuant to Section 45 of Chapter 3 of the Acts of 1992, the *Dental Act*, is pleased to approve the making by the Provincial Dental Board of Nova Scotia of amendments to the *Specialists Regulations* approved by the Governor in Council by Order in Council 93-858 dated November 2, 1993, in the manner set forth in Schedule "A" attached to and forming part of the report and recommendation, effective on and after October 10, 2002.

Amendments to the Specialists Regulations made pursuant to Section 45 of Chapter 3 of the Acts of 1992, the Dental Act

The *Specialists Regulations* approved by the Governor in Council by Order in Council 93-858 dated November 2, 1993, are amended by striking out Section 7 and substituting the following Section:

- 7 The Registrar may issue a Specialty Certificate to a person who
 - (a) is licensed to engage in the practice of dentistry under the Act;
 - (b) has successfully completed a specialty program that is accredited by the Commission on Dental Accreditation of Canada or the American Dental Association Commission on Dental Accreditation:
 - has successfully completed a national specialty examination process approved by the Board;
 - (d) is in good standing in the profession; and
 - (e) pays the fee prescribed by the Board for certification as a specialist.
