Additionally they require significant revision to bring them up to date and in agreement with other portions of the *Nova Scotia Crop and Livestock Insurance Act*.

Therefore, I certify that at a meeting held on September 18, 2008, the Nova Scotia Crop and Livestock Insurance Commission, pursuant to Section 6 of Chapter 113 of the Revised Statues [Statutes] of Nova Scotia, 1989, the *Nova Scotia Crop and Livestock Insurance Act*, passed a motion to repeal the following:

Order in Council 2008-658 dated December 18, 2008 Amendment to regulations made by the Governor in Council pursuant to Section 50 of the *Liquor Control Act* 

The Governor in Council on the report and recommendation of the Minister of Labour and Workforce Development dated December 11, 2008, and pursuant to Section 50 of Chapter 260 of the Revised Statutes of Nova Scotia, 1989, the *Liquor Control Act*, is pleased to amend the *Liquor Licensing Regulations*, N.S. Reg. 365/2007, made by the Governor in Council by Order in Council 2007-445 dated August 17, 2007, to set a minimum drink price in establishments with liquor licences, in the manner set forth in Schedule "A" attached to and forming part of the report and recommendation, effective on and after December 19, 2008.

#### Schedule "A"

Amendment to the Liquor Licensing Regulations made by the Governor in Council pursuant to Section 50 of Chapter 260 of the Revised Statutes of Nova Scotia, 1989, the Liquor Control Act

The *Liquor Licensing Regulations*, N.S. Reg. 365/2007, made by the Governor in Council by Order in Council 2007-445 dated August 17, 2007, are amended by adding the following Section immediately after Section 50:

#### Licensee not to sell liquor below minimum price

- **50A** (1) A licensee must not offer for sale or supply a serving of liquor for less than a total purchase price of \$2.50, including any applicable taxes.
  - (2) For the purposes of subsection (1), a serving of liquor is prescribed, by volume and type, as follows:
    - (a) 355 ml (12 oz.) of beer, cider or cooler;
    - (b) 29 ml (1 oz.) of spirits;
    - (c) 142 ml (5 oz.) of wine;
    - (d) 85 ml (3 oz.) of fortified wine.
  - (3) If a licensee offers for sale or supply a serving of liquor that differs from the volume prescribed in subsection (2), the minimum price for that serving must increase or decrease in direct proportion to the difference between the volume of liquor contained in that serving and the volume prescribed in subsection (2).
