TO ALL TO WHOM THESE PRESENTS SHALL COME, OR WHOM THE SAME MAY IN ANY WISE CONCERN,

GREETING:

A PROCLAMATION

WHEREAS in and by Our Writs for the election of Members to serve in the House of Assembly for the several Electoral Districts of the Province bearing date the 5th day of May, 2009, the respective Returning Officers of the said Districts are commanded to summon the persons elected according to the exigency of the said Writs to attend the General Assembly of Nova Scotia at such time and place as We shall notify by Proclamation for that purpose;

NOW KNOW YE THAT WE, being desirous and resolved as soon as may be to meet Our People of Our Province of Nova Scotia and to have their advice in General Assembly do hereby, by and with the advice of Our Executive Council for Nova Scotia, appoint Thursday, the 25th day of June, next, at Halifax, in the Halifax Regional Municipality, for the meeting of the General Assembly of Nova Scotia;

AND WE DO HEREBY require the Members who were elected to service in the House of Assembly to attend in General Assembly on that day at Halifax, in the Halifax Regional Municipality aforesaid, of which they and all others concerned are to take notice and govern themselves accordingly.

IN TESTIMONY WHEREOF We have caused these our Letters to be made Patent and the Great Seal of Nova Scotia to be hereunto affixed.
