Whereas the purpose of the *Petroleum Products Pricing Regulations* is to ensure just and reasonable prices for specified petroleum products taking into consideration the objectives of preserving the availability of such products in rural areas, stabilizing prices of such products and minimizing the variances in prices of such products across the Province;

And whereas the Nova Scotia Utility and Review Board ("Board") considered the manner in which it would proceed to set petroleum prices in its decision, 2006 NSUARB 108, issued on October 16, 2006;

And whereas the average of the average of the daily high and low reported product prices (in Canadian cents) for the week ended August 4, 2010, are:

Grade 1 Regular gasoline 56.8¢ per litre Ultra-low-sulfur diesel oil 59.1¢ per litre

Now therefore the Board prescribes the benchmark prices for petroleum products to be:

Gasoline:

Grade 1 56.8¢ per litre
Grade 2 59.8¢ per litre
Grade 3 62.8¢ per litre
Ultra-low-sulfur diesel oil 59.1¢ per litre

And now therefore the Board has determined, based on historical data regarding price changes and to achieve revenue neutrality, it is appropriate to apply, and the Board so orders, forward averaging corrections of:

Gasoline: plus 0.5ϕ per litre Ultra-low-sulfur diesel oil: plus 0.6ϕ per litre

And now therefore the Board prescribes the prices for petroleum products as set forth in Schedule "A" effective on and after 12:01 a.m., August 6, 2010.

Amendment to regulations made by the Executive of the Board of the Nova Scotia College of Optometrists and approved by the Governor in Council pursuant to Section 19 of the *Optometry Act*

The Governor in Council on the report and recommendation of the Minister of Health dated July 20, 2010, and pursuant to Section 19 of Chapter 43 of the Acts of 2005, the *Optometry Act*, is pleased to approve amendments made by the Executive of the Board of the Nova Scotia College of Optometrists, as delegated under Section 20 of Chapter 43 of the Acts of 2005, the *Optometry Act*, to the *Optometry Regulations*, N.S. Reg. 453/2007, made by the Executive of the Board of the Nova Scotia College of Optometrists and approved by the Governor in Council by Order in Council 2007-638 dated December 17, 2007, to increase the required continuing education hours, in the manner set forth in Schedule "A" attached to and forming part of the report and recommendation, effective on and after August 10, 2010.

under Section 19, as delegated under Section 20, of Chapter 43 of the Acts of 2005,
the *Optometry Act*

The *Optometry Regulations*, N.S. Reg. 453/2007, made by the Executive of the Board of the Nova Scotia College of Optometrists and approved by the Governor in Council by Order in Council 2007-638 dated December 17, 2007, are amended by repealing subsection 7(1) and substituting the following subsection:

(1) Except as provided in subsection (2), an optometrist must complete at least 55 hours of approved continuing education in optometry in each 3-year period referred to in Section 6.

Gasoline: minus 0.2ϕ per litre Ultra-low-sulfur diesel oil: plus 0.2ϕ per litre

And now therefore the Board prescribes the prices for petroleum products as set forth in Schedule "A" effective on and after 12:01 a.m., August 13, 2010.
