Regulations Respecting Milk Categories and Classes
[Amendment to the Milk Classes and Categories Regulations]
made under clauses 8(d) and 9(r) of Chapter 24 of the Acts of 2000,
the Dairy Industry Act

- 1 Section 4, Class 2(e) of these regulations is amended by striking out "meal replacements," and "infant formula,".
- 2 Repeal and replace the row of information Section 4, Class 4(a)1 under Section 4, with the following:

Milk components for the manufacture of rennet casein (dry or curd), milk protein concentrate (dry or liquid) or skim milk (dry or liquid) to be used in the manufacture of non-standardized final products in the processed cheese category.

Schedule A

Amendment to the *Milk Pricing Regulations* made by the Dairy Farmers of Nova Scotia under clauses 14(1)(c) and 15(1)(g) of Chapter 24 of the Acts of 2000, the *Dairy Industry Act*

- 1 The *Milk Pricing Regulations*, N.S. Reg. 84/2008, made by the Dairy Farmers of Nova Scotia on September 21, 2007, and approved by the Natural Products Marketing Council on February 12, 2008, are amended by adding the following in Section 1A:
 - (c) "premium payment certified organic milk" means certified organic milk for which the Board is required to pay a 20% premium to producers in accordance with the DFNS Organic Milk Policy.

- 2 Subsection 3(1), Class 4 (c) of the regulations is amended by striking out "85% of the Class 4(a) component prices" and substituting "84.69% of the Class 2, 3(a), 3(b), 4(a), 4(b), and 4(d) component prices".
- 3 Subsection 3(3) of the regulations is repealed and replaced with the following:
 - (3) Processors in Nova Scotia must pay a premium of an additional 20% of the prices in subsection (1) for milk components of premium payment certified organic milk that are processed into dairy products in which all of the milk components are from certified organic milk.
- 4 Subsection 5(3) of the regulations is repealed and replaced with the following:
 - (3) The Board must calculate an equalized premium, based on the premiums paid under subsection 3(3), and allocate this premium equitably among all producers selling premium payment certified organic milk in accordance with the DFNS Organic Milk Policy.

Whereas the purpose of the *Petroleum Products Pricing Regulations* is to ensure just and reasonable prices for specified petroleum products taking into consideration the objectives of preserving the availability of such products in rural areas, stabilizing prices of such products and minimizing the variances in prices of such products across the Province;

And whereas the Nova Scotia Utility and Review Board ("Board") considered the manner in which it would proceed to set petroleum prices in its decision, 2006 NSUARB 108, issued on October 16, 2006;

And whereas the average of the average of the daily high and low reported product prices (in Canadian cents) for the week ended May 12, 2010, are:

Grade 1 Regular gasoline 56.4¢ per litre Ultra-low-sulfur diesel oil 59.6¢ per litre

Now therefore the Board prescribes the benchmark prices for petroleum products to be:

Gasoline:

Grade 1 56.4ϕ per litre Grade 2 59.4ϕ per litre Grade 3 62.4ϕ per litre Ultra-low-sulfur diesel oil 59.6ϕ per litre

And now therefore the Board has determined, based on historical data regarding price changes and to achieve revenue neutrality, it is appropriate to apply, and the Board so orders, forward averaging corrections of:

Gasoline: nil Ultra-low-sulfur diesel oil: nil

And now therefore the Board prescribes the prices for petroleum products as set forth in Schedule "A" effective on and after 12:01 a.m., May 14, 2010.

The Governor in Council on the report and recommendation of the Minister of Justice dated April 27, 2010, and pursuant to Section 18 of Chapter 450 of the Revised Statutes of Nova Scotia, 1989, the *Summary Proceedings Act*, is pleased to amend the *Investigative Warrant Enactment Regulations*, N.S. Reg. 118/2006, made by the Governor in Council by Order in Council 2006-336 dated July 19, 2006, to appropriately reflect legislation that is currently in force, in the manner set forth in Schedule "A" attached to and forming part of the report and recommendation, effective on and after May 18, 2010.

And now therefore the Board has determined, based on historical data regarding price changes and to achieve revenue neutrality, it is appropriate to apply, and the Board so orders, forward averaging corrections of:

Gasoline: minus 1.1ϕ per litre Ultra-low-sulfur diesel oil: minus 1.2ϕ per litre

And now therefore the Board prescribes the prices for petroleum products as set forth in Schedule "A" effective on and after 12:01 a.m., May 21, 2010.
