And whereas the Nova Scotia Utility and Review Board ("Board") considered the manner in which it would proceed to set petroleum prices in its decision, 2006 NSUARB 108, issued on October 16, 2006;

And whereas the average of the average of the daily high and low reported product prices (in Canadian cents) for the week ended September 14, 2011, are:

Grade 1 Regular gasoline 75.0¢ per litre Ultra-low-sulfur diesel oil 78.4¢ per litre

Now therefore the Board prescribes the benchmark prices for petroleum products to be:

Gasoline:

Grade 1 75.0¢ per litre
Grade 2 78.0¢ per litre
Grade 3 81.0¢ per litre
Ultra-low-sulfur diesel oil 78.4¢ per litre

And now therefore the Board has determined, based on historical data regarding price changes and to achieve revenue neutrality, it is appropriate to apply, and the Board so orders, forward averaging corrections of:

Gasoline: minus 0.7ϕ per litre Ultra-low-sulfur diesel oil: minus 0.2ϕ per litre

And now therefore the Board prescribes the prices for petroleum products as set forth in Schedule "A" effective on and after 12:01 a.m., September 16, 2011.

Order in Council 2011-344 dated September 13, 2011 Designation made by the Governor in Council pursuant to Section 16 of the *Public Service Act*

The Governor in Council on the report and recommendation of the Minister of Economic and Rural Development and Tourism, dated September 6, 2011, and pursuant to Section 16 of Chapter 376 of the Revised Statutes of Nova Scotia, 1989, the *Public Service Act*, is pleased to:

- (a) designate the tourism marketing and industry development secretariat of the Department of Economic and Rural Development and Tourism as a special operating agency, to be known as the Nova Scotia Tourism Agency; [N.S. Reg. 274/2011]
- (b) establish an interim operating charter for the special operating agency designated under clause (a), containing the objects of the special operating agency, and terms, conditions and other provisions governing its operations as outlined in Schedule "A" attached to and forming part of the report and recommendation of the Minister of Economic and Rural Development and Tourism dated September 6, 2011; and [Clause (b) not filed as a regulation.]
- (c) authorize the Minister of Economic and Rural Development and Tourism to execute such agreements, documents and instruments as may be required to give effect to this Order. [Clause (c) not filed as a regulation.]
