Whereas the purpose of the *Petroleum Products Pricing Regulations* is to ensure just and reasonable prices for specified petroleum products taking into consideration the objectives of preserving the availability of such products in rural areas, stabilizing prices of such products and minimizing the variances in prices of such products across the Province;

And whereas the Nova Scotia Utility and Review Board ("Board") considered the manner in which it would proceed to set petroleum prices in its decision, 2006 NSUARB 108, issued on October 16, 2006;

And whereas the Board revised the retail margin and transportation allowance effective January 6, 2012, in its decision, 2011 NSUARB 181, issued on November 23, 2011;

And whereas the average of the average of the daily high and low reported product prices (in Canadian cents) for the week ended October 24, 2012, are:

Grade 1 Regular gasoline 69.3¢ per litre Ultra-low-sulfur diesel oil 83.0¢ per litre

Now therefore the Board prescribes the benchmark prices for petroleum products to be:

Gasoline:

Grade 1 69.3¢ per litre
Grade 2 72.3¢ per litre
Grade 3 75.3¢ per litre
Ultra-low-sulfur diesel oil 83.0¢ per litre

And now therefore the Board has determined, based on historical data regarding price changes and to achieve revenue neutrality, it is appropriate to apply, and the Board so orders, forward averaging corrections of:

Gasoline: minus 1.5ϕ per litre Ultra-low-sulfur diesel oil: minus 0.5ϕ per litre

And whereas a winter blending adjustment of plus 1.5ϕ per litre is required for ultra-low-sulfur diesel oil;

And now therefore the Board prescribes the prices for petroleum products as set forth in Schedule "A" effective on and after 12:01 a.m., October 26, 2012.

- (a) amend the *Summary Offence Tickets Regulations*, N.S. Reg. 281/2011, made by order of the Attorney General and Minister of Justice dated October 4, 2011, to designate certain offences under the *Snow Sport Helmet Act* as summary offence ticket offences, in the manner set forth in the attached Schedule "A"; and
- (b) order and direct that the penalty to be entered on a summons in respect of an offence set out in amendments to the schedules to the *Summary Offence Tickets Regulations*, N.S. Reg. 281/2011, as set forth in the attached Schedule "A", is the out-of-court settlement amount listed in the out-of-court settlement column set out opposite the description for the offence, and includes the charge provided for in, and in accordance with, Sections 8 and 9 of the Act.

Amendment to regulations made by the Nova Scotia Crop and Livestock Insurance Commission and approved by the Governor in Council pursuant to Section 6 of the Crop and Livestock Insurance Act

The Governor in Council on the report and recommendation of the Minister of Agriculture dated October 10, 2012, and pursuant to Section 6 of Chapter 113 of the Revised Statutes of Nova Scotia, 1989, the *Crop and Livestock Insurance Act*, is pleased to approve of amendments made by the Nova Scotia Crop and Livestock Insurance Commission to the *Crop Insurance Plan for Strawberries*, N.S. Reg. 6/95, made by the Commission and approved by the Governor in Council by Order in Council 95-21 dated January 3, 1995, in the manner set forth in Schedule "A" attached to and forming part of the report and recommendation, effective on and after October 30, 2012.

I certify that the Nova Scotia Crop and Livestock Insurance Commission, at a meeting held April 21, 2011, passed a motion to amend the *Crop Insurance Plan for Strawberries*, N.S. Reg. 6/95, approved by the Governor in Council by Order in Council 95-21 dated January 3, 1995, in the manner set out in the attached.

The amendments to the regulations referred to above are effective on and after the date they are approved by the Governor in Council.

Amendment to the Crop Insurance Plan for Strawberries made by the Nova Scotia Crop and Livestock Insurance Commission under Section 6 of Chapter 113 of the Revised Statutes of Nova Scotia, 1989, the Crop and Livestock Insurance Act

Subsection 3(1) of the *Crop Insurance Plan for Strawberries*, N.S. Reg. 6/95, approved by the Governor in Council by Order in Council 95-21 dated January 3, 1995, is amended by striking out the definition of "strawberries" and substituting the following definition:

"strawberries" means varieties of strawberries accepted by the Commission for insurance coverage in either of the following 2 crop types:

- (i) June-bearing,
- (ii) day-neutral.
- 2 Clause 4(d) of the plan is repealed and the following clause substituted:
 - (d) fall frost,
 - (i) for June-bearing varieties, at any time during the crop year, and
 - (ii) for day-neutral varieties, up to and including September 30;
- 3 Subsection 5(1) of the plan is repealed and the following subsection substituted:
 - (1) The crop year for strawberries is as follows:
 - (a) for June-bearing varieties, the period from September 1 in any year to August 31 in the next year;
 - (b) for day-neutral varieties, the period from April 1 in any year to September 30 in the same year.
- 4 Section 6 of the plan is repealed and the following Section substituted:
 - 6 For the purpose of clause 4(2)(b) of the General Regulations, an application for a contract of insurance under this plan must be filed with the Commission
 - (a) for June-bearing varieties, before November 15 in the 1st crop year for which the contract of insurance is to be in force;
 - (b) for day-neutral varieties, before March 31 in advance of each crop year for which the contract of insurance is to be in force.
- 5 The plan is further amended by adding the following Section immediately after Section 6:

Duration of contract for day-neutral varieties

- A contract of insurance under this plan for day-neutral varieties expires at the end of the crop year to which it applies and is not continued in force for subsequent crop years.
- 6 Section 8 of the plan and its heading are repealed and the following Section and heading substituted:

Deadline for notice of cancellation for June-bearing varieties

- 8 For the purpose of clause 4(1)(a) of the terms and conditions of the Contract of Insurance, a notice of cancellation of insurance under this plan for June-bearing varieties must be given no later than September 15 of the crop year for which the cancellation is to be effective.
- 7 The plan is further amended by adding the following heading and Section immediately after Section 14:

Final planting date for day-neutral varieties

- **14A** Day-neutral varieties must be planted by May 31 of the crop year.
- 8 Section 17 of the plan is repealed and the following Section substituted:
 - 17 The final dates for insurance protection under this plan are August 31 for June-bearing varieties and September 30 for day-neutral varieties, or any other dates determined by the Commission.

Regulations Respecting Number Plates for Farmers and Fishermen made by the Minister of Service Nova Scotia and Municipal Relations under Section 38 of Chapter 293 of the Revised Statutes of Nova Scotia, 1989, the *Motor Vehicle Act*

Citation

1 These regulations may be cited as the *Number Plates for Farmers and Fishermen Regulations*.

Definitions

2 In these regulations,

"farmer" means a person

- (i) who resides on a farm and derives the major part of their income from that farm, or
- (ii) who operates a farm that gives employment to 1 or more persons on a full-time basis;

"fisherman" means

(i) a person who holds a valid commercial fishing vessel registration under the *Fisheries Act* (Canada) and a valid registration card issued under Section 36 of the *Revenue Act Regulations* made under the *Revenue Act*, or

(ii) a person who holds an aquaculture licence issued under the *Fisheries and Coastal Resources Act*:

"FM number plate" means a special number plate issued under these regulations to a farmer or a fisherman.

Description of FM number plate

- 3 An FM number plate must
 - (a) have dimensions of 15.24 cm in width by 30.48 in length;
 - (b) bear the words "Nova Scotia" at the top;
 - (c) bear the letters "FM" followed by random numbers; and
 - (d) be in general accordance with the number plate depicted in Schedule A.

Eligibility for FM number plate

On application to the Department in the form approved by the Registrar, and subject to these regulations, a farmer or fisherman may be issued an FM number plate.

Plate issue and display restrictions

- 5 (1) An FM number plate may be issued only to a farmer or fisherman.
 - (2) An FM number plate may be displayed only on
 - (a) a commercial truck that is owned or leased by the farmer or fisherman who was issued the plate; or
 - (b) a passenger van with a minimum seating capacity of 7 that is owned or leased by the farmer or fisherman who was issued the plate.

Vehicle use restrictions

- 6 (1) A driver must not use a vehicle bearing an FM number plate issued to a farmer for any of the following purposes:
 - (a) to transport any passenger for gain;
 - (b) as transportation to or from the driver's employment, other than employment related to the farmer's farm business;
 - (c) to carry goods for gain, unless the goods are for the use of or products of a farm that is located in the Province.
 - (2) A driver must not use a vehicle bearing an FM number plate issued to a fisherman for any of the following purposes:
 - (a) to transport any passenger for gain;
 - (b) as transportation to or from the driver's employment, other than employment related to the fisherman's fishing business;
 - (c) to carry goods for gain, unless the goods are for the use of or products of a fisherman.

1 These regulations may be cited as the *Registration Fees for Farmers and Fishermen Regulations*.

1 These regulations may be cited as the *Snow Sport Helmet Regulations*.

Helmet standards

- A helmet required by subsection 5(1) of the Act must meet the standards set out in the latest edition of the standards for helmets for recreational skiing and snowboarding of 1 or more of the following certification agencies:
 - (a) American Society for Testing and Materials;
 - (b) Central European Committee for Standardization;
 - (c) Canadian Standards Association;
 - (d) Snell Memorial Foundation.

Notification signs

- 3 (1) A notification sign required by subsection 6(1) of the Act must be in the form set out in Appendix A and must measure 46 cm in width and 61 cm in height.
 - (2) A notification sign must be displayed at a point of purchase in accordance with all of the following conditions:
 - (a) it must be displayed within 1 m of each cash register where lift tickets are for sale;
 - (b) it must be readily legible and unobstructed;
 - (c) it must be clearly visible to the customer at the point of purchase.
 - (3) A notification sign must be displayed at a lift entrance in accordance with all of the following conditions:
 - (a) it must be displayed at the entrance to all ski lifts;
 - (b) it must be clearly visible to persons before loading the ski lift;
 - (c) it must be readily legible and unobstructed.
 - (4) Notification signs must be obtained from the Department of Health and Wellness.

Whereas the purpose of the *Petroleum Products Pricing Regulations* is to ensure just and reasonable prices for specified petroleum products taking into consideration the objectives of preserving the availability of such products in rural areas, stabilizing prices of such products and minimizing the variances in prices of such products across the Province;

And whereas the Nova Scotia Utility and Review Board ("Board") considered the manner in which it would proceed to set petroleum prices in its decision, 2006 NSUARB 108, issued on October 16, 2006;

And whereas the Board revised the retail margin and transportation allowance effective January 6, 2012, in its decision, 2011 NSUARB 181, issued on November 23, 2011;

And whereas the average of the average of the daily high and low reported product prices (in Canadian cents) for the week ended October 31, 2012, are:

Grade 1 Regular gasoline 72.5¢ per litre Ultra-low-sulfur diesel oil 83.6¢ per litre

Now therefore the Board prescribes the benchmark prices for petroleum products to be:

Gasoline:

Grade 1 72.5¢ per litre
Grade 2 75.5¢ per litre
Grade 3 78.5¢ per litre
Ultra-low-sulfur diesel oil 83.6¢ per litre

And now therefore the Board has determined, based on historical data regarding price changes and to achieve revenue neutrality, it is appropriate to apply, and the Board so orders, forward averaging corrections of:

Gasoline: minus 0.3ϕ per litre

Ultra-low-sulfur diesel oil: nil

And whereas a winter blending adjustment of plus 2.1¢ per litre is required for ultra-low-sulfur diesel oil;

And now therefore the Board prescribes the prices for petroleum products as set forth in Schedule "A" effective on and after 12:01 a.m., November 2, 2012.
