The Governor in Council on the report and recommendation of the Minister of Finance dated June 13, 2013, and pursuant to Section 9 of Chapter 43 of the Acts of 2010, the *Public Sector Compensation Disclosure Act*, is pleased to make new regulations respecting the time and manner of disclosure for certain public sector bodies in the form set forth in Schedule "A" attached to and forming part of the report and recommendation, effective on and after July 23, 2013.

Schedule "A"

Regulations Respecting the Time and Manner of Disclosure of Compensation by Public Sector Bodies made by the Governor in Council under Section 9 of Chapter 43 of the Acts of 2010,

the Public Sector Compensation Disclosure Act

Citation

1 These regulations may be cited as the *Time and Manner of Disclosure Regulations*.

Definitions

2 In these regulations,

"Act" means the Public Sector Compensation Disclosure Act;

"Public Accounts" has the same meaning as in the *Finance Act*.

Application of regulations

These regulations apply to public sector bodies described in subclauses 2(f)(i) and (ii) of the Act.

Time and manner of disclosure

- 4 (1) The information required to be disclosed under the Act must be disclosed in the following manner:
 - (a) in the form approved by the Minister of Finance, as posted on the Department of Finance's website:
 - (b) in an electronic format approved by the Minister of Finance, that enables the Minister to post the information in a publicly accessible manner on the Department of Finance's website.
 - (2) The information required to be disclosed under the Act must be disclosed by the following dates:
 - (a) to the Minister of Finance, on a date determined by the Minister of Finance in each year that is before the date the Public Accounts are tabled in the House of Assembly;
 - (b) on the public sector body's own website, on the same date as the date the Public Accounts are tabled in the House of Assembly.
