And whereas the Nova Scotia Utility and Review Board ("Board") considered the manner in which it would proceed to set petroleum prices in its decision, 2006 NSUARB 108, issued on October 16, 2006;

And whereas the Board revised the retail margin and transportation allowance effective January 6, 2012, in its decision, 2011 NSUARB 181, issued on November 23, 2011;

And whereas the Board revised the wholesale margin effective January 4, 2013, in its decision, 2012 NSUARB 213, issued on December 12, 2012;

And whereas the average of the average of the daily high and low reported product prices (in Canadian cents) for the week ended May 6, 2015, are:

Grade 1 Regular gasoline 62.6¢ per litre Ultra-low-sulfur diesel oil 63.7¢ per litre

Now therefore the Board prescribes the benchmark prices for petroleum products to be:

Gasoline:

Grade 1 62.6¢ per litre
Grade 2 65.6¢ per litre

1 These regulations may be cited as the *Pension Benefits Act Fees Regulations*.

Definitions

- 2 (1) In these regulations,
 - "Act" means the *Pension Benefits Act*;
 - "Pension Benefits Regulations" means the Pension Benefits Regulations made under the Act.
 - (2) A term defined in the *Pension Benefits Regulations* has the same meaning when used in these regulations.

Fees must accompany documents

3 All fees must accompany any required documents on application, filing, submission or request unless otherwise required by these regulations.
