**Whereas** the purpose of the *Petroleum Products Pricing Regulations* is to ensure just and reasonable prices for specified petroleum products taking into consideration the objectives of preserving the availability of such products in rural areas, stabilizing prices of such products and minimizing the variances in prices of such products across the Province;

And whereas the Nova Scotia Utility and Review Board ("Board") considered the manner in which it would proceed to set petroleum product prices in its decision, 2006 NSUARB 108, issued on October 16, 2006;

And whereas the Board revised the wholesale margin effective January 4, 2013, in its decision, 2012 NSUARB 213, issued on December 12, 2012;

And whereas the Board revised the retail margin and the transportation allowance effective October 28, 2016, in its decision, 2016 NSUARB 168, issued on September 26, 2016;

And whereas the average of the average of the daily high and low reported product prices (in Canadian cents) for the week ended June 28, 2017, are:

Grade 1 Regular gasoline	49.8¢ per litre
Ultra-low-sulfur diesel oil	48.3¢ per litre

Now therefore the Board prescribes the benchmark prices for petroleum products to be:

49.8¢ per litre

I certify that on May 30, 2017, the Chicken Farmers of Nova Scotia, pursuant to Section 9 of Chapter 308 of the Revised Statutes of Nova Scotia, 1989, the *Natural Products Act*, as delegated by Section 7 of the *Nova Scotia Chicken Marketing Plan*, N.S. Reg. 241/82, carried a motion to amend the *Chicken Farmers of Nova Scotia Regulations*, N.S. Reg. 11/2005, approved by the Natural Products Marketing Council on December 8, 2004, in the manner set forth in the attached Schedule "A", effective on and after January 21, 2018.

# Schedule "A"

## Amendment to the *Chicken Farmers of Nova Scotia Regulations* made by the Chicken Farmers of Nova Scotia pursuant to Section 9 of Chapter 308 of the Revised Statutes of Nova Scotia, 1989, the *Natural Products Act*

- 1 Subsection 2(1) of the *Chicken Farmers of Nova Scotia Regulations*, N.S. Reg. 11/2005, approved by the Natural Products Marketing Council on December 8, 2004, is amended by
  - (a) adding the following definitions immediately after the definition of "A–07":

"A7-0001" means the 7-week marketing period from January 21, 2018 to March 17, 2018, inclusive;

"A7-0002" means the 7-week marketing period immediately following A7-0001;

(b) repealing the definition of "overmarketing assessment period" and substituting the following definition:

"overmarketing assessment period" means 2 consecutive marketing periods as follows:

- (i) for 8-week licences, A-06 and A-07, and every subsequent 2 consecutive 8-week marketing periods after that, and
- (ii) for 7-week licences, A7-0001 and A7-0002, and every subsequent 2 consecutive 7-week marketing periods after that;
- (c) adding the following definition immediately after the definition of "partnership":

"periodic base quota" means the portion of a producer's base quota applicable to 1 marketing period, calculated using the formula  $PBQ = (BQ/357) \times 56$ , in which

- (i) PBQ is the producer's periodic base quota, and
- (ii) BQ is the producer's base quota;
- (d) repealing the definition of "quota allocation" and substituting the following definition:

"quota allocation" means the total number of kilograms of chicken allocated by the Chicken Farmers of Canada to the Commodity Board for A-06 and for each subsequent 8-week marketing period after that, expressed in kilograms of live weight;

- 2 Section 9 of the regulations is amended by adding the following subsection immediately after subsection (7):
  - (8) Licences involved in a transfer must have been issued for the same marketing period.
- 3 (1) Subsection 10(1) of the regulations is amended by
  - (a) striking out the period at the end of clause (c) and substituting a semicolon; and
  - (b) adding the following clause immediately after clause (c):
    - (d) the number of weeks in the licence period.
  - (2) Subsection 10(5) of the regulations is repealed and the following subsection substituted:
    - (5) A producer who markets less than 96% of the production standard prescribed by the total producer licences issued to that producer over a time period prescribed in subsection (5A) must appear before the Commodity Board to explain why less chicken was marketed than was licensed for.
  - (3) Section 10 of the regulations is further amended by adding the following subsection immediately after subsection (5):

- (5A) A prescribed time period referred to in subsection (5) is as follows:
  - (a) for a producer with an 8-week licence, a base quota period;
  - (b) for a producer with a 7-week licence, a period covering
    - (i) 8 7-week marketing periods beginning with A7-0001, or
    - (ii) any subsequent 8 consecutive 7-week marketing periods after the period referred to in subclause (i).
- 4 Subsection 11(1) of the regulations is repealed and the following subsection substituted:
  - (1) Subject to subsection (2) and Section 10, the kilograms of live weight of chicken for each producer licence is based on the length of the marketing period for which the licence is issued and the lesser of
    - (a) the producer's maximum barn capacity; and
    - (b) the producer's periodic base quota as adjusted by that producer's share of any increase or decrease from the quota allocation for the marketing period, but any increase or decrease remains subject to sections 8F, 8G, and 8H.
- 5 Subsection 12(1) of the regulations is repealed and the following subsection substituted:
  - 12 (1) Before each marketing period, a producer holding a producer licence and a processor must enter into a production and marketing agreement for that marketing period, which must be in the form approved by the Commodity Board and must specify all of the following:
    - (a) the number of chickens to be placed with the producer;
    - (b) the target average weight for each chicken at marketing;
    - (c) the scheduled processing week for the chickens that are placed;
    - (d) the marketing period covered by the agreement.
