And whereas the Nova Scotia Utility and Review Board ("Board") considered the manner in which it would proceed to set petroleum product prices in its decision, 2006 NSUARB 108, issued on October 16, 2006;

**And whereas** the Board revised the wholesale margin effective January 4, 2013, in its decision, 2012 NSUARB 213, issued on December 12, 2012;

And whereas the Board revised the retail margin and the transportation allowance effective October 28, 2016, in its decision, 2016 NSUARB 168, issued on September 26, 2016;

**And whereas** the average of the average of the daily high and low reported product prices (in Canadian cents) for the week ended April 4, 2018, are:

Grade 1 Regular gasoline 68.4¢ per litre Ultra-low-sulfur diesel oil 67.7¢ per litre

**Now therefore** the Board prescribes the benchmark prices for petroleum products to be:

Grade 1 68.4¢ per litre
Grade 2 71.4¢ per litre
Grade 3 74.4¢ per litre

#### Memorandum of Agreement Between

Her Majesty the Queen in the Right of the Province of Nova Scotia Represented by the Minister of Finance

and

the Nova Scotia Teachers' Union a body corporate established pursuant to the *Teaching Profession Act*, being Chapter 462 of the Revised Statutes of Nova Scotia, 1989

Whereas Sections 14 and 20 of Chapter 26 of the Acts of 1998, the *Teachers' Pension Act* provides that the Minister of Finance ("the Minister") and the Nova Scotia Teachers' Union ("the Union") may make regulations setting out the terms of the Teachers' Pension Plan ("the Pension Plan");

**And whereas** the *Teachers' Pension Plan Regulations* ("the Regulations") were made as of March 31, 1999, as N.S. Reg. 88/1999;

**And whereas** the By-laws of the Union, as amended by Resolution 2000-15, authorize the Executive of the Union to exercise on behalf of the Union the powers of the Union under the *Teachers' Pension Act*;

**And whereas** by resolution of the Executive of the Union dated January 19, 2018, the Executive approved the amendments to the Regulations as set out in Schedule "A" attached hereto and authorized the President of the Union to sign the amendments to the Regulations on behalf of the Executive;

The Minister and the Union hereby amend the Regulations in the manner set forth in the attached Schedule "A", effective on and after February 1, 2018.

- Subsection 2(2) of the *Teachers' Pension Plan Regulations*, N.S. Reg. 88/1999, made by the Minister of Finance and the Nova Scotia Teachers' Union on March 31, 1999, is amended by
  - (a) adding "and Treasury Board" immediately after "Minister of Finance" in clause (w);
  - (b) repealing subclause 2(2)(y)(iv);
  - (c) amending clause (al) by
    - (i) striking out "of the same or opposite sex",
    - (ii) striking out ", or" at the end of subclause (iii), and adding the following subclause immediately after subclause (iii):
      - (iiia) are domestic partners within the meaning of Section 52 of the Vital Statistics Act, or
  - (d) adding the following clause immediately after clause (ana):
    - (anb) "Teachers' Pension Board" means the Teachers' Pension Board established under an agreement concerning the Pension Plan and the Fund dated June 22, 2005, between the Province and the Union, and continued under an agreement concerning the Pension Plan and the Fund dated July 2, 2014, between the Province and the Union;
- 2 Subsection 4(2A) of the regulations is amended by
  - (a) striking out "between August 1, 2000 and July 31, 2018" and substituting "commencing on or after August 1, 2000";
  - (b) striking out "he was" in clause (a) and substituting "they were";
  - (c) adding "and" immediately after the semicolon at the end of clause (b);
  - (d) striking out "; and" at the end of clause (c) and substituting a period; and
  - (e) repealing clause (d).
- 3 Clause 12(3)(a) of the regulations is amended by adding "service" immediately before "prior to January 1, 1966".
- 4 Subsection 13(2) of the regulations is amended by striking out "Sections" and substituting "Section".
- 5 Clause 18(2)(b) of the regulations is amended by striking out "subclauses (3)(a)(i) and (ii)" and substituting "subclauses (a)(i) and (ii)".
- 6 Clause 20(b) of the regulations is repealed and the following clause substituted:

- (b) where the deceased member had no spouse as of the date of death, to
  - (i) a designated beneficiary, or
  - (ii) if there is no designated beneficiary, to the estate of the deceased member.
- 7 (1) Clause 21(12)(a) of the regulations is repealed and the following clause substituted:
  - (a) a member, the total contributions of the member, with interest as set out in Section 29, shall be paid to
    - (i) a designated beneficiary, or
    - (ii) if there is no designated beneficiary, to the estate of the deceased member;
  - (2) Subclause 21(12)(b)(ii) of the regulations is repealed and the following subclause substituted:
    - (ii) in the absence of children specified in subclause (i), to
      - (A) a designated beneficiary, or
      - (B) if there is no designated beneficiary, the estate of the deceased former member, or
      - (C) if there is no designated beneficiary and the estate of the deceased former member has been closed, the estate of the deceased spouse of the deceased former member, provided the spouse was the last person to receive a survivor pension.

  - (1) The interest rate, for a given school year, attributable to interest payable in respect of refunds of contributions, on which interest shall be calculated from August 1 following the end of the school year for which the contributions were made to the date of payment of the refund, shall be at a rate equal to the average yield for the 12-month period ending on October 31 in the preceding calendar year, of the 5-year personal fixed term chartered bank deposit rate as determined from the Canadian Socio-Economic Information Management (CANSIM) Series B 14045 published in the Bank of Canada Review, and shall be compounded annually.
  - (1A) The interest rate attributable to interest payable in respect of payments of commuted values, on which interest shall be calculated from the effective date of the commuted value to the date payment of the commuted value is made, shall be at a rate equal to the rate used to calculate the commuted value.
