Whereas the purpose of the *Petroleum Products Pricing Regulations* is to ensure just and reasonable prices for specified petroleum products taking into consideration the objectives of preserving the availability of such products in rural areas, stabilizing prices of such products and minimizing the variances in prices of such products across the Province;

And whereas the Nova Scotia Utility and Review Board (Board) considered the manner in which it would proceed to set petroleum product prices in its decision, 2006 NSUARB 108, issued on October 16, 2006;

And whereas the Board revised the wholesale margin effective January 4, 2013, in its decision, 2012 NSUARB 213, issued on December 12, 2012;

And whereas the Board revised the retail margin and the transportation allowance effective October 28, 2016, in its decision, 2016 NSUARB 168, issued on September 26, 2016;

And whereas the average of the average of the daily high and low reported product prices (in Canadian cents) for the week ended June 13, 2018, are:

Grade 1 Regular gasoline	70.5¢ per litre
Ultra-low-sulfur diesel oil	74.3¢ per litre

Now therefore the Board prescribes the benchmark prices for petroleum products to be:

The Governor in Council on the report and recommendation of the Minister of Transportation and Infrastructure Renewal dated May 29, 2018, and pursuant to Section 38 of Chapter 293 of the Revised Statutes of Nova Scotia, 1989, the *Motor Vehicle Act*, is pleased to approve new regulations made by the Minister of Transportation and Infrastructure Renewal respecting Mi'kmaq number plates, in the form set forth in Schedule "A" attached to and forming part of the report and recommendation, effective on and after June 21, 2018.

I, Lloyd Hines, Minister of Transportation and Infrastructure Renewal for the Province of Nova Scotia, under Section 38 of Chapter 293 of the Revised Statutes of Nova Scotia, 1989, the *Motor Vehicle Act*, hereby make regulations respecting Mi'kmaq number plates in the form set forth in the attached, effective on and after the date this Order is approved by the Governor in Council.

Regulations Respecting Mi'kmaq Number Plates made by the Minister of Transportation and Infrastructure Renewal under Section 38 of Chapter 293 of the Revised Statutes of Nova Scotia, 1989, the *Motor Vehicle Act*

Citation

1 These regulations may be cited as the *Mi'kmaq Number Plates Regulations*.

Definitions

2 In these regulations,

"Mi'kmaq number plate" means a special number plate as described in Section 3;

"Mi'kmaw Youth Fund" means the Mi'kmaw Youth Fund established as a special purpose fund under Section 10 of the *Finance Act*.

Description of plate

- 3 On application to the Registrar of Motor Vehicles in the form approved by the Registrar, an eligible person may be issued a special number plate that
 - (a) is 15.24 cm in width by 30.48 cm in length;
 - (b) shows a Mi'kmaq petroglyph, a round symbol with 8 stars in it, on the top left followed by blue letters and numerals on a silver white field; and
 - (c) bears the words "NOVA SCOTIA" at the top and the words "MI'KMA'KI LAND OF THE MI'KMAQ" on the bottom centre, and is otherwise in general accordance with the number plate depicted in Schedule A.

Eligibility for initial Mi'kmaq number plate

4 A person who has made a contribution of \$24 to the Mi'kmaw Youth Fund is eligible to apply for a Mi'kmaq number plate.

Maintaining Mi'kmaq number plate

5 A person who has been issued a Mi'kmaq number plate may retain the plate if a \$24 donation is made to the Mi'kmaw Youth Fund each time the permit for the motor vehicle the plate is issued for is renewed.

Vehicle weight restriction

6 A Mi'kmaq number plate may be issued only for a vehicle that is a passenger motor vehicle or a commercial motor vehicle and has a registered weight of 5000 kg or less.
