> Order in Council 2018-237 dated September 4, 2018 Amendment to regulations made by the Governor in Council pursuant to Section 13 of the *Housing Nova Scotia Act*

The Governor in Council on the report and recommendation of the Minister of Community Services dated July 24, 2018, and pursuant to Section 13 of Chapter 213 of the Revised Statutes of Nova Scotia, 1989, the *Housing Nova Scotia Act*, is pleased to amend the *Day Care Assistance Regulations*, N.S. Reg. 442/2008, made by the Governor in Council by Order in Council 2008-638 dated December 9, 2008, to provide for financial assistance to child care providers, in the manner set forth in Schedule "A" attached to and forming part of the report and recommendation, effective on and after September 4, 2018.

Schedule "A"

Amendment to the *Day Care Assistance Regulations* made by the Governor in Council under Section 13 of Chapter 213 of the Revised Statutes of Nova Scotia, 1989, the *Housing Nova Scotia Act*

- 1 Section 1 of the *Day Care Assistance Regulations*, N.S. Reg. 442/2008, made by the Governor in Council by Order in Council 2008-638 dated December 9, 2008, is amended by striking out "*Day Care Assistance Regulations*" and substituting "*Child Care Assistance Regulations*".
- 2 Sections 2 and 3 of the regulations are repealed and the following Sections substituted:

Definitions for Act and regulations

2 (1) In these regulations,

"child care services" means any of the following:

- (i) services described in the definition of "day care" in clause 2(a) of the *Day Care Act*,
- (ii) a public school program for children who will be at least 4 years old on December 31 of the school year in which they are enrolled, as described in clause 3(2)(g) of the *Day Care Regulations* made under the *Day Care Act*,
- (iii) a private school program for children who will be at least 4 years old on December 31 of the school year in which they are enrolled, as described in clause 3(2)(h) of the *Day Care Regulations* made under the *Day Care Act*,
- (iv) a pre-primary program under the *Pre-primary Education Act*.
- (2) For the purposes of the Act and these regulations, "human habitation" includes a facility used to provide child care services.

Corporation may provide financial assistance

3 (1) The Corporation may provide financial assistance in the form of a grant, loan or forgivable

loan, in accordance with the policies and programs of the Corporation, for the purpose of assisting a person to construct or improve a facility that is used or will be used to provide child care services.

(2) The approval of a grant, loan or forgivable loan referred to in subsection (1) and the advancement of funds is at the sole discretion of the Corporation.

Whereas the purpose of the *Petroleum Products Pricing Regulations* is to ensure just and reasonable prices for specified petroleum products taking into consideration the objectives of preserving the availability of such products in rural areas, stabilizing prices of such products and minimizing the variances in prices of such products across the Province;

And whereas the Nova Scotia Utility and Review Board (Board) considered the manner in which it would proceed to set petroleum product prices in its decision, 2006 NSUARB 108, issued on October 16, 2006;

And whereas the Board revised the wholesale margin effective January 4, 2013, in its decision, 2012 NSUARB 213, issued on December 12, 2012;

And whereas the Board revised the retail margin and the transportation allowance effective October 28, 2016, in its decision, 2016 NSUARB 168, issued on September 26, 2016;

And whereas the average of the average of the daily high and low reported product prices (in Canadian cents) for the week ended September 10, 2018 [*sic*], are:

> Order dated September 18, 2018 Repeal of regulations and regulations made by the Minister of Environment pursuant to clause 8A(1)(c) of the *Environment Act*

In the matter of clause 8A(1)(c) of Chapter 1 of the Acts of 1994-95, the *Environment Act*

In the matter of regulations adopting a mercury diversion standard made by the Minister of Environment under clause 8A(1)(c) of the *Environment Act*

Order

I, Margaret Miller, Minister of Environment for the Province of Nova Scotia, pursuant to clause 8A(1)(c) of Chapter 1 of the Acts of 1994-95, the *Environment Act*, hereby

- (a) repeal the regulations adopting the standard published by the Department of Environment on January 1, 2015, as the standard that applies to mercury diversion under the *Air Quality Regulations*, N.S. Reg. 195/2014, made by order of the Minister of Environment dated December 11, 2014; and
- (b) make new regulations adopting a standard that applies to mercury diversion under the *Air Quality Regulations*, in the form set forth in the attached Schedule "A".

This order is effective on and after the date it is made.

Schedule "A"

Regulations Respecting Adoption of a Mercury Diversion Standard made under clause 8A(1)(c) of Chapter 1 of the Acts of 1994-95, the *Environment Act*

Citation

1 These regulations may be cited as the *Mercury Diversion Standard Adoption Regulations*.

Adopted standard

2 The *Mercury Diversion Standard* developed by the Department of Environment, as amended or replaced from time to time, is adopted by the Minister of Environment under clause 8A(1)(c) of the *Environment Act* as the standard that applies to mercury diversion under the *Air Quality Regulations*.

Public availability

- **3** The standard adopted by these regulations must be available to the public, clearly identifying amendments and effective dates, as follows:
