Whereas the purpose of the *Petroleum Products Pricing Regulations* is to ensure just and reasonable prices for specified petroleum products taking into consideration the objectives of preserving the availability of such products in rural areas, stabilizing prices of such products and minimizing the variances in prices of such products across the Province;

And whereas the Nova Scotia Utility and Review Board ("Board") considered the manner in which it would proceed to set petroleum product prices in its decision, 2006 NSUARB 108, issued on October 16, 2006;

And whereas the Board revised the wholesale margin effective January 4, 2013, in its decision, 2012 NSUARB 213, issued on December 12, 2012;

And whereas the Board revised the retail margin and the transportation allowance effective October 28, 2016, in its decision, 2016 NSUARB 168, issued on September 26, 2016;

And whereas the Board has determined that due to a significant decrease in the price of diesel oil that it is appropriate to adjust the most recently prescribed weekly prices by the Board;

Now therefore the Board prescribes the benchmark prices for petroleum products to be:

NOW KNOW YE THAT WE, by and with the advice of the Executive Council of Nova Scotia, do by this Our Proclamation order and declare that that Sections 1, 4 and 5 of Chapter 13 of the Acts of 2020, *An Act to Amend Chapter 246 of the Revised Statutes*, *1989, the Labour Standards Code, Respecting Leave*, do come into force on and not before May 5, 2020, of which all persons concerned are to take notice and govern themselves accordingly.

The Governor in Council on the report and recommendation of the Minister of Labour and Advanced Education dated April 14, 2020, and pursuant to Section 7 of Chapter 246 of the Revised Statutes of Nova Scotia, 1989, the Labour Standards Code, is pleased, effective on and after May 5, 2020, to amend the General Labour Standards Code Regulations, N.S. Reg. 298/1990, made by the Governor in Council by Order in Council 90-1321 dated November 13, 1990, to repeal the reservist leave provisions to align with the Labour Standards Code, repeal and replace a reference to universities designated under the University Foundations Act to align with amendments made to that Act, and clarify language relating to the incorporation documentation that must be provided by applicants for foreign worker recruitment licences.

Amendment to the General Labour Standards Code Regulations made by the Governor in Council under Section 7 of Chapter 246 of the Revised Statutes of Nova Scotia, 1989, the Labour Standards Code

- 1 Subsection 1A(1) of the General Labour Standards Code Regulations, N.S. Reg. 298/1990, made by the Governor in Council by Order in Council 90-1321 dated November 13, 1990, is amended by
 - (a) striking out the period at the end of the definition of "mobile home" and substituting a semicolon; and
 - (b) adding the following definition immediately after the definition of "mobile home":

"university" means any of the following:

- (i) Acadia University,
- (ii) Atlantic School of Theology,
- (iii) Cape Breton University,
- (iv) Dalhousie University,
- (v) Mount Saint Vincent University,
- (vi) Nova Scotia College of Art and Design,
- (vii) St. Francis Xavier University,
- (viii) Saint Mary's University,
- (ix) Université Sainte-Anne,

- (x) University of King's College.
- 2 Clause 2(14)(c) of the regulations is repealed and the following clause substituted:
 - (c) a university; and
- 3 Clause 7A(1)(n) of the regulations is repealed and the following clause substituted:
 - (n) the operation of a ferry or boat authorized by a competent authority to carry passengers on uniform closing days;
- 4 Section 7B of the regulations is repealed.
- 5 Subsection 11(1) of the regulations is amended by adding "the" immediately before "purposes".
- 6 Subclause 15(3)(j)(iii) of the regulations is repealed and the following subclause substituted:
 - (iii) if the recruitment will be conducted by a corporation,
 - (A) all of the following documents for the corporation:
 - (I) the memorandum of association, articles of incorporation or equivalent document in the jurisdiction in which the corporation was incorporated,
 - (II) the articles of association, bylaws or equivalent document in the jurisdiction in which the corporation was incorporated,
 - (B) the certificate of incorporation of the corporation,
 - (C) any shareholders' agreement for the corporation;
