Whereas the purpose of the *Petroleum Products Pricing Regulations* is to ensure just and reasonable prices for specified petroleum products taking into consideration the objectives of preserving the availability of such products in rural areas, stabilizing prices of such products and minimizing the variances in prices of such products across the Province;

And whereas the Nova Scotia Utility and Review Board ("Board") considered the manner in which it would proceed to set petroleum product prices in its decision, 2006 NSUARB 108, issued on October 16, 2006;

And whereas the Board revised the wholesale margin effective January 4, 2013, in its decision, 2012 NSUARB 213, issued on December 12, 2012;

And whereas on December 30, 2020, the Board issued an interim order in Matter M09952 increasing the wholesale margin for self-service and full-service gasoline and diesel, on an interim basis, by 2.50 cents per litre (cpl) to a total of 9.15 cpl;

And whereas the Board revised the retail markup and the transportation allowance effective October 28, 2016, in its decision, 2016 NSUARB 168, issued on September 26, 2016, and on February 1, 2021, the Board issued an order in Matter M09727 approving an increase to the minimum self-service and full-service retail markup by 0.3 cpl and to the maximum self-service retail markup by 0.4 cpl, to a total for the minimum of 5.4 cpl, and for the maximum of 7.4 cpl;

And whereas the average of the average of the daily high and low reported product prices (in Canadian cents) for the period ended March 3, 2021, are:

Grade 1 Regular gasoline	64.04¢ per litre
Ultra-low-sulfur diesel oil	61.51¢ per litre

Now therefore the Board prescribes the benchmark prices for petroleum products to be:

64.04¢ per litre
67.04¢ per litre
70.04¢ per litre
61.51¢ per litre

And now therefore the Board has determined, based on historical data regarding price changes and to achieve revenue neutrality, it is appropriate to apply, and the Board so orders, forward averaging corrections of:

> Gasoline: Ultra-low-sulfur diesel oil:

plus 1.90¢ per litre plus 1.10¢ per litre

And whereas a winter blending adjustment of plus 2.14¢ per litre is required for ultra-low-sulfur diesel oil;

And now therefore the Board prescribes the prices for petroleum products as set forth in Schedule "A" effective on and after 12:01 a.m., March 5, 2021.

## Memorandum of Agreement Between Her Majesty the Queen in the Right of the Province of Nova Scotia Represented by the Minister of Finance and Treasury Board and the Nova Scotia Teachers' Union A Body Corporate Established Pursuant to the *Teaching Profession Act*, Being Chapter 462 of the Revised Statutes of Nova Scotia, 1989

**Whereas** Sections 14 and 20 of Chapter 26 of the Acts of 1998, the *Teachers' Pension Act* provide that the Minister of Finance ("the Minister") and the Nova Scotia Teachers' Union ("the Union") may make regulations setting out the terms of the Teachers' Pension Plan ("the Pension Plan");

And whereas the *Teachers' Pension Plan Regulations* ("the regulations") were made as of March 31, 1999, as N.S. Reg. 88/1999;

And whereas the By-laws of the Union, as amended by Resolution 2000-15, authorize the Executive of the Union to exercise on behalf of the Union the powers of the Union under the *Teachers' Pension Act*;

And whereas by resolution of the Executive of the Union dated February 25, 2021, the Executive approved the amendments to the regulations as set out in Schedule "A" attached hereto and authorized the President of the Union to sign the amendments to the regulations on behalf of the Executive;

The Minister and the Union hereby make the amendments to the regulations in the form and manner attached hereto as Schedule "A", effective on and after August 1, 2021.

## Amendment to the *Teachers' Pension Plan Regulations* Made by the Minister of Finance and Treasury Board and the Nova Scotia Teachers' Union pursuant to Sections 14 and 20 of Chapter 26 of the Acts of 1998, the *Teachers' Pension Act*

- 1 Section 3 of the *Teachers' Pension Plan Regulations*, N.S. Reg. 88/1999, made by the Minister of Finance and the Nova Scotia Teachers' Union, effective March 31, 1999, is amended by
  - (a) striking out "April 1, 2019, and July 31, 2020" and substituting "August 1, 2021 and July 31, 2022" in subsection (2A); and
  - (b) adding the following subsection immediately after subsection (2A):
    - (2B) When determining if a person referred to in subsection (2A) teaches less than 100 days as a substitute teacher in one school year between August 1, 2021, and July 31, 2022, re-employment pursuant to subsection (2) must be combined with re-employment as a substitute teacher pursuant to subsection (2A).
- 2 Section 11 of the regulations is amended by
  - (a) striking out "April 1, 2019, and July 31, 2021" and substituting "August 1, 2021, and July 31, 2022" in subsection (1A);
  - (b) striking out "April 1, 2019, and July 31, 2021" and substituting "August 1, 2021, and July 31, 2022" in subsection (2A);
  - (c) striking out "August 1, 2020 and July 31, 2021" and substituting "August 1, 2021, and July 31, 2022" in subsection (2B);
  - (d) striking out "April 1, 2019, and July 31, 2021" and substituting "August 1, 2021, and July 31, 2022" in subsection (4A); and
  - (e) striking out "August 1, 2020 and July 31, 2021" and substituting "August 1, 2021, and July 31, 2022" in subsection (4B).

The *Median Crossing Regulations*, N.S. Reg. 233/2009, made by the Minister of Transportation and Infrastructure Renewal by Order dated June 4, 2009, are amended by repealing clause 3(1)(a) and substituting the following clause:

- (a) a vehicle that is being operated by a person during the course of their duties, if the person is any one of the following:
  - (i) a conservation officer appointed under an enactment,
  - (ii) an inspector appointed under Section 34 of the *Motor Carrier Act*,

- (iii) a fishery officer or fishery guardian designated under subsection 5(1) of the *Fisheries Act* (Canada),
- (iv) an officer designated under subsection 12(1) of the *Wild Animal and Plant Protection and Regulation of International and Interprovincial Trade Act* (Canada),
- (v) a game officer designated under subsection 6(1) of the *Migratory Birds Convention Act, 1994* (Canada),
- (vi) an enforcement officer designated under subsection 85(1) of the Species at Risk Act (Canada),
- (vii) a wildlife officer designated under Section 11 of the Canada Wildlife Act (Canada);
