- (a) pursuant to subsection 37(4) of Chapter 4 of the Acts of 2023, the *Road Trails Act*, make regulations respecting off-highway vehicle insurance and passengers in the form set forth in Schedule "A" attached to and forming part of the report and recommendation;
- (b) pursuant to Section 25 of Chapter 323 of the Revised Statutes of Nova Scotia, 1989, the *Off-highway Vehicles Act*,
 - (i) amend the *Off-highway Vehicles Designated Trails and Trail Permit*[s] *Regulations*, N.S. Reg. 224/2006, made by the Governor in Council by Order in Council 2006-534 dated December 8, 2006, to update language and insert a reference to the *Road Trails Act*, in the manner set forth in Schedule "B" attached to and forming part of the report and recommendation, and
 - (ii) amend the *Off-highway Vehicles General Regulations*, N.S. Reg. 13/1988, made by the Governor in Council by Order in Council 88-66 dated February 1, 1988 [January 21, 1988], to clarify how off-highway vehicles may be used in the ditch areas of controlled access highways, in the manner set forth in Schedule "C" attached to and forming part of the report and recommendation; and
- (c) pursuant to Section 307 of Chapter 293 of the Revised Statutes of Nova Scotia, 1989, the *Motor Vehicle Act*, repeal the *Off-highway Vehicle Pilot Project Regulations*, N.S. Off-highway Vehicles Insurance and Passenger Regulations

Schedule "A"

Regulations Respecting Off-highway Vehicles Insurance and Passengers made by the Governor in Council under Section 37 of Chapter 4 of the Acts of 2023, the Road Trails Act

Citation

1 These regulations may be cited as the *Off-highway Vehicles Insurance and Passenger Regulations*.

Definitions

2 In these regulations,

"Act" means the Road Trails Act;

"authorized insurer" means an authorized insurer as defined in the Motor Vehicle Act;

"motor vehicle liability policy" means a motor vehicle liability policy as defined in Part VI of the *Insurance Act*;

"proof of financial responsibility" means a certificate in a form approved by the Registrar that is issued to the owner of an off-highway vehicle as evidence that a motor vehicle liability insurance policy is in force.

Insurance

In the Act and its regulations, "third-party liability insurance" means insurance under a motor vehicle liability policy that provides the insurance coverage in accordance with Sections 139 and 140 of the *Insurance Act* for an off-highway vehicle.

Amount of third-party liability insurance

4 The minimum amount of third-party liability insurance an owner of an off-highway vehicle is required to maintain under Section 10 of the Act with an authorized insurer for each off-highway vehicle they own is the amount required by the *Insurance Act*.

Form and filing of proof of financial responsibility

- 5 (1) An individual who is issued a motor vehicle liability insurance policy for an off-highway vehicle in accordance with these regulations may request that the insurer file proof of financial responsibility on their behalf with the Registrar.
 - (2) The Registrar may request any further information the Registrar considers necessary.

Proof of financial responsibility for non-resident owner

- A person who is not a resident of the Province may file proof of financial responsibility in accordance with Section 5 or may file a certificate of insurance in a form approved by the Registrar issued by any insurer authorized to transact insurance in the province or state in which the person resides, if the insurer files all of the following with the Registrar:
 - (a) a power of attorney authorizing the Registrar to accept service of notice or process for the insurer and its insured in any action or proceeding in a court of law arising out of an off-highway vehicle accident in the Province;
 - (b) an undertaking to appear in any action or proceeding in a court of law involving a motor vehicle liability policy issued by it that it has knowledge of;
 - (c) an undertaking not to set up as a defence to any claim, action or proceeding under a motor vehicle liability policy issued by it that might not be set up if the policy had been issued in the Province in accordance with the law of the Province relating to motor vehicle liability policies;
 - (d) an undertaking to satisfy, up to the limits of liability stated in the policy, any judgment rendered by a court in the Province that is final against it or its insured.

Proof of financial responsibility is conclusive

Proof of financial responsibility filed in accordance with Section 5 or a certificate of insurance filed in accordance with Section 6 is conclusive admission by the insurer that a motor vehicle liability policy has been issued for the off-highway vehicles owned by the insured.

Registrar may refuse proof of responsibility

8 The Registrar may refuse to accept proof of financial responsibility from an insurer who fails to honour their obligations under a motor vehicle liability policy or these regulations for as long as the failure continues.

Passengers

- 9 An operator of an off-highway vehicle must not permit a passenger on the vehicle unless
 - (a) the vehicle is designed to carry passengers; and
 - (b) there is a designated seat for the passenger.

Offences and penalties

10 A person who violates Section 9 is guilty of an offence and liable on summary conviction to the penalties provided for a category F offence in the *Summary Proceedings Act*.

Reg. 224/2006, made by the Governor in Council by Order in Council 2006-534 dated December 8, 2006, is amended by striking out "Lands and Forestry" in the definition of "Minister" and substituting "Natural Resources and Renewables".
- 2 Clause 4(b) of the regulations is amended by striking out "Transportation and Infrastructure Renewal's" and substituting "Public Works".
- 3 Section 4A of the regulations is amended by
 - (a) striking out "Transportation and Infrastructure Renewal" and substituting "Public Works" in subsection (1); and
 - (b) striking out "Transportation and Infrastructure and Renewal" and substituting "Public Works" in subsection (2).
- 4 Section 17 of the regulations is repealed and the following Section substituted:

Operation of OHV on portion of public highway

An OHV may be operated on a portion of a highway that has been designated as a trail only if operated in accordance with the *Road Trails Act* or pilot project regulations made under Section 307 of the *Motor Vehicle Act*.

Controlled access highways

No person shall operate or drive an off-highway vehicle upon or across a roadway, shoulder or median of a highway designated as a controlled access highway pursuant to the *Public Highways Act* except as authorized under the *Road Trails Act*.



Appendix A: Sherbrooke Area


Two sections of road travel:

- 1. Trail intersects with Highway 7 near Sherbrooke, Guysbrough County at east 579559, north 4999516 and travels in an easterly direction along Highway 7 for 490 m to the intersection of Highway 7 and Main Street. Then northeast 635 m to the intersection of Highway 7 and Old Road Hill. Northeast along Old Road Hill 100 m to the intersection of existing trail.
- 2. Beginning at the Intersection of Highway 7 and Main Street, travel southwest along Main Street to the intersection of Main [Street] and Court Street. Then easterly along Court Street 90 m to east 579965, north 4999086.




Appendix B: Weymouth Area

Trail begins where the former rail bed intersects with Highway 1, north of Weymouth, Digby County, at coordinates east 261483, north E 4921956. Then 810 m along Highway 1 to the intersection of Route 340, Weymouth Falls Road and Highway 1. Then westerly, 1060 m along Highway 1 to the intersection of existing trail on former rail bed at coordinates east 737944 north 4921282.




Appendix C: New Germany Area

Trail begins where the former rail bed intersects with Maple Drive, New Germany (near Fire Hall), Lunenburg County, at coordinates east 363164, north 4934130. Then southwest crossing Highway 10 and travelling 210 m to the intersection of Highway 10 and Varner Road coordinates east 363012, north 4934000.



Appendix D: Porters Lake Area


Beginning at a point on the Myra Road, Porters Lake, Halifax County, coordinates east 469553, north 4961722 and travelling in a northerly direction for 110 m to an existing trail at east 469608, north 4961806.



Appendix E: Walton Area


Two sections of road travel:

- 1. Trail intersects with the Bancroft Road near Walton, Hants County, at coordinates east 420682, north 5008242. Then north 250 m, along the Bancroft Road to the intersection of the Shore Road, then 375 m along the Shore Road to the intersection of Route 215. Then northeast along Route 215, 365 m to the intersection of the Walton Woods Road. Then easterly along the Walton Woods Road 1340 m to the intersection of the McBurney Road, then 1600 m along McBurney Road to coordinates east 424055, north 5008790.
- 2. Beginning at the intersection of Route 215 and Walton [Woods] Road, then northwest along Route 215, 290 m to the intersection of Route 215 and Odd Fellows Hall Road, coordinates east 421023, north 5009038.



Appendix F: Gabarus Area

Trail begins where a K-class road intersects with Oceanview Road at east 720627, north 5084878 and travelling in a southerly direction along Oceanview Road, 2822 m to the intersection of Oceanview Road and Route 327. Then southerly along Route 327, 2667 m to the intersection of Route 327 and a Crown road at east 718244, north 5080351.



Appendix G: Ship Harbour Area

Trail begins at the location where Ferry Road (K-class road) intersects with West Ship Harbour Road at coordinates east 511962, north 4960235. Then 3300 m in a northwesterly direction along West Ship Harbour Road and Trunk 7. Then 340 m northwesterly along Trunk 7 to the intersection of Trunk 7 and Bruce Drive (a private lane) at coordinates east 509010, north 4961793.

Schedule "A"

Regulations Respecting Equipment for Off-highway Vehicles made by the Minister of Public Works under Section 37 of Chapter 4 of the Acts of 2023, the Road Trails Act

Citation

1 These regulations may be cited as the *Off-highway Vehicles Equipment Regulations*.

Equipment in good working order

2 Safety equipment on an off-highway vehicle installed by the manufacturer must be maintained in good working order.

Headlamps

- 3 (1) A person must not operate an off-highway vehicle on a road trail unless the light from its headlamps meets all of the following requirements:
 - (a) it is white and the lens and bulb of the headlamp is made of clear untinted glazing;

- (b) it is of sufficient intensity to reveal a person, another vehicle or an object that is at least 150 m ahead;
- (c) it is aimed so that, on a straight and level surface, the high intensity portion of the beam does not shine in the eyes of an approaching driver.
- (2) A person must not attach or apply anything to a headlamp, a part of a headlamp or the bulb of a headlamp that colours the light from the headlamp.

Tail lamps

- A person must not operate an off-highway vehicle on a road trail unless it has a tail lamp that meets all of the following requirements:
 - (a) at least 1 tail lamp is mounted to the rear of the vehicle;
 - (b) the tail lamp is capable of emitting a red light that is visible from at least 150 m to the rear of the vehicle;
 - (c) the tail lamp is red.

Side mirror

A side mirror must be affixed in a manner that provides a clear view of the roadway behind and to the side of the vehicle so that an approaching vehicle is clearly visible to the driver of the off-highway vehicle.

Brake system

A person must not operate an off-highway vehicle on a road trail unless the off-highway vehicle is equipped with a brake system that is sufficiently powerful to stop the vehicle quickly in case of an emergency and hold the vehicle stationary.

Helmets

- A person operating an off-highway vehicle must wear a helmet that bears a mark indicating that the helmet is approved or certified as a helmet for the appropriate class of off-highway vehicle by 1 or more of the following certification agencies:
 - (a) the British Standards Institute;
 - (b) the Snell Memorial Foundation;
 - (c) the U.S. Department of Transportation;
 - (d) the Economic Commission for Europe.

Offences and penalties

- 8 (1) A person who violates subsection 3(1) or (2) or Section 4 is guilty of an offence and liable on summary conviction to the penalties provided for a category A offence in the *Summary Proceedings Act*.
 - (2) A person who violates Section 5 or 6 is guilty of an offence and liable on summary conviction to the penalties provided for a category C offence in the *Summary Proceedings Act*.
 - (3) A person who violates Section 7 is guilty of an offence and liable on summary conviction to the penalties provided for a category F offence in the *Summary Proceedings Act*.
