## Technical Safety Standards Regulations – Adoption of Updated Boiler and Pressure Equipment Codes

By Ministerial Order effective February 7, 2023, updated versions of twenty-one (21) Boiler and Pressure Equipment (BPE) codes have been adopted through amendments to the *Technical Safety Standards Regulations*.

The updated codes are in force as of February 7, 2023. Industry will be granted a 90-day period from the date of issue of this Safety Bulletin to adjust any current work procedures and processes prior to any compliance and enforcement action.
